# **Position Summary:**

Assists in the general upkeep of funeral home and cemetery equipment, appearance and systems including heating, cooling, plumbing, painting, mowing/clipping, car washing and overall maintenance of cemetery grounds and crematory.

- 5. Seasonal maintenance of cemetery grounds as required, trimming shrubs, trees, etc.
- 6. Assist with setting of markers as needed.
- 7. Clean and pressure wash sidewalks, statuary, and fencing as needed at cemetery.
